Please note that classified staff or appointed personnel (excluding post docs) must have held their position in EEB for a minimum of 3 months to be eligible for nomination. Those who have received the award in the past two years are also ineligible. A list of available staff members is attached.

The Department is now soliciting nominations for the Outstanding Staff Award. EEB faculty, staff and students may submit nominations. A committee will review the nominations and select an individual for this award.
